### RESULTS FOR QUARTER ENDED 31 MARCH 2012

During the quarter Eurogold sub-underwrote \$10,000,000 of a renounceable rights issue by Dragon Mining Limited (ASX:DRA) to raise \$15,000,000.

Eurogold's share of the shortfall was 3,963,820 shares at a cost of \$4,360,202.

As a consequence of that issue and the resulting shortfall, Eurogold now has a relevant interest of 24.45% of the issued shares in Dragon Mining.

As previously announced, Eurogold committed to a funding facility of \$10,000,000 with its major shareholder, the Allied Group of Hong Kong and has drawn down \$1,000,000 of the facility.

On 29 February 2012 the Company announced that it had sold the balance of its holding in Tanami Gold NL (ASX:TAM) for a profit of approximately \$450,000.

As at today's date the Company's share portfolio has a value of \$19 million and a current NAV of \$0.23 per share.

The Company continues to examine various investment opportunities in resource projects with a particular interest in the gold mining sector but for various reasons the acquisition of projects reviewed to date have not proceeded.

It is not the intention of the Board that the primary business of Eurogold will be that of a passive portfolio investor.
