RESULTS FOR QUARTER ENDED 30 JUNE 2011

During the quarter the Company increased its holding in Dragon Mining Limited to 19.25%. The Company's other principle holding is a 3.57% interest in Tanami Gold NL.

Eurogold's worth is directly related to the shareprice of these two stocks. With the price of Tanami at \$1.05 and Dragon Mining at \$1.40 the NAV of Eurogold is \$0.37 per share.

The Company continues to examine various investment opportunities in resource projects with a particular interest in the gold mining sector but for various reasons the acquisition of projects reviewed to date have not proceeded.

It is not the intention of the Board that the primary business of Eurogold will be that of a passive portfolio investor.
